MEMBERSHIP NOTES

Thomas N. Bisson, University of California at Berkeley, has published: "L'essor de la Catalogne: identité et idéologie dans une société du XIIE siècle," Annales: Économies, Sociétés, Civilisations (1984). He has been invited to give lectures during 1983 and 1984 on the subject of Catalonia at Cambridge, Oxford, Ghent and Zürich. He has been awarded the Premio Javier Conde Garriga by the Asociación Numismatica Española for his book, Conservation of Coinage. Professor Bisson continues his research in early medieval France, the history and genealogy of southern France and the Pyrenees in the eleventh and twelfth centuries, and fiscal accounts in the twelfth-century West.

Thomas M. Izbicki is preparing a translation of Juan de Torquemada's Oratio synodalis de primatu.

Connie L. Scarborough of Denison University has received a faculty research grant for study in Madrid during the summer of 1984. Her recent papers include "The Figure of Doña Sancha and the Epic Legend of El Infante Don García," "Moorish Devotion to the Virgin as Seen in the Cantigas de Santa Maria," and "Alfonso X: A Monarch in Search of a Miracle."

MEDIEVAL SPANISH LAW

Professor H.T. Sturcken wishes to sell his collection of medieval Spanish law. Included are original print editions and microfilms (indicated by *). Among the fueros in the collection are those of Cuenca (Ureña's edition), Usagre (Ureña), Miranda de Ebro (ed. Cantera Burgos), Molina de Aragón (Sancho Izquierdo), Zorita de los Canes (Ureña), the Leonese fueros of Zamora, Salamanca, Ledesma and Alba de Tormes (Castro), Coria (Maldonado), Soria*(Galo Sánchez), Verviesca* (Sanz García), Llanes (Bonilla)*, Madrid* (Galo Sanchez, Ayala* (Uriarte Lebario). There is also the Fuero viejo de Castilla (1771 ed.), Fuero Juzgo (1815 ed.), the Ordenanzas de Ojacastro and the Fueros del Reyno de Navarra. Other related studies and texts include: Crónica de España of Lucas of Tuy (1926 ed.), Documentos para la historia de las intituciones de León y de Castilla, ed. E. de Hinojosa, Estudios jurídicos del Fuero de Bizkaya, ed. J. de Solano, and others.

REVIEW

The Sala Family Archive; A Handlist of Medieval and Early Modern Catalonian Charters, ed. and intro. Joseph J. Gwara, Jr. Washington, D.C.: Georgetown University Press, 1984. \$6.95.

This volume is a calendar of some 289 charters, dated between 1261 and 1690, that derive from the castle archive of Montorroell, an estate located some 16 kilometers north of Vic, and which are now housed principally at Georgetown University. Their subject is the normal routine of business: bills of sale, receipts, tenant leases, marriage contracts, wills, etc. The collection illustrates in particular the history of the Sala family which owed the estate from 1371 until the late sixteenth century. In addition to the calendar itself -- this briefly describes each charter, cites its initial line, and summarizes its contents --, there is also a useful introduction that sketches the history of Montorroell and the development of this particular collection. Except for a minor geographical lapse that locates Ripoll to the south of Barcelona, all of this is well done. As the editor points out, this is one of the few medieval Catalan manuscript collections located in the United States. Thus, it has importance not only in itself as a source for local history, but also as a convenient resource for the introduction of American students to the use of medieval sources. Gwara is to be commended for drawing this collection to our attention and for facilitating its exploration.
